April 4, 2022

Approval of Agenda: was by consensus.

Approval of Minutes: Minutes of the March 07, 2022 meeting were approved on a motion by M. Perry and second by M. Gould.

Comments From The Floor: Representative Carra updated the trustees about the happenings at the State Capitol. He is mostly negative about an increase in the state budget.

The Annual budget hearing opened at 6:10 PM.

2. Letts presented the Burr Oak Township 2022- 2023 Budget for review.
3. Depository for funds: Checking account is at Century Bank & Trust; Certificates of Deposit are with South Michigan Bank

 - E. Fire Dept. Equipment Fund (Fund Balance: \$7,73.58)
 - F. A motion to approve the 2022- 2023 Fund balances by M. Gould with a second by M. Perry passed on a roll call vote, with all four members present voting YES.

Treasurers Report: Treasurer Gould gave the report: Checking account balance: \$3,834.96; Money Market balance: \$122,446.19. Total: \$126,281.15. Letts moved to receive the Treasurers Report and place it on file. M. Perry seconded the motion. The motion passed with all four trustees voting yes.

Assessor's Report: Assessor Hutson reported to Supervisor Letts that the Township Commercial Property had been undervalued, so commercial property owners will be receiving a corrected tax bill.

Unfinished Business: The Board will wait until their May 9 meeting to finalize the names/requests for dust control in 2023.

New Business: The Second Reading of the 2022-2023 Burr Oak Township budget. M. Perry moved to approve the Burr Oak Township 2022 – 2023 Budget as presented with a second by G. Letts. Roll call taken with the four members present voting YES.

Township Clean-up Day will be Saturday April 23, 2022, from 8 AM to 12 Noon. This will be in conjunction with the Village of Burr Oak. M. Gould will supervise the first two hours and G. Letts the last two hours.

Memorial Day Service will be May 30, 2022, at 1 O'clock P.M. at the Township Cemetery. Letts will contact participants as in previous years, for participation. Jackie will order flowers for the Tomb of the Unknown Soldier.

Marijuana Ordinances, The Planning committee has approved all the Marijuana Ordinances.

1. Ordinance #2022 -01: **(Rules for applications)** was moved by G. Letts with a second by M.Perry. Roll call taken with all four members present voting YES. No signatures required.

Ordinances #2022-02 **(Regulate and License Recreational Marihuana Establishments)** was moved by J. Wells with a second by M. Gould to approve. Roll call taken with all four members present voting YES. Signatures required.

Ordinance #2022-03 (**Definitions**) moved by M. Perry with a second by M. Gould to approve. Roll call vote taken with all four members present voting YES. Signatures required.

Ordinance 2022 – 04 (**Marihuana licensing application, rules, appeals, and fee schedule**). Moved by M. Perry with a second by M. Gould to approve the ordinance. Roll call vote taken with all four members present voting YES. Clerk signature required.

Ordinance 2022 – 5 (**Licensing Fee Schedule**) moved by G. Letts with a second by J. Wells to approve. Roll call taken with all four members present voting YES. No signature required.

All Ordinances effective April 4, 2022.

Cemetery Need quotes for trail cameras for Cemetery security.

M. Gould moved to purchase a 7'x 16' trailer to move the mower and necessary mowing equipment for \$4355.00, with a second by M. Perry. After lengthy discussion, the motion was approved.

Sexton R. Ultz continues work on storm damage to the various Township cemeteries. He will install the NO DUMPING signs at the main Burr Oak Township Cemetery.

Treasurer Gould will keep checking on the purchase of a pickup truck for Township use.

Planning Board: next meeting April 18, 2022

Fire Department - Interlocal Agreement with the Village of Burr Oak has been approved. (signatures required)

Ambulance Committee – still in progress and being discussed.

Legal Updates: Cell Phone Tower application on Dwight Road in the works. Lance Thornton Township attorney, resigned his position after serving 25 years. Roxanne Seeber of Bauckham, Sparks, Thall, Seeber & Kaufman, P.C. will be the new attorney for Burr Oak Township. L. Thornton presented a bill for work on various Township items. It was decided by consensus to pay this current bill.

Payment of Bills: G. Letts moved to pay the current Township bills which totaled \$11,325.57 with a second by M. Perry. The motion passed without objection.

With no further business to be conducted, the meeting was adjourned at 8:02 P.M. The next meeting will be May 9, 2022 at 6:00 PM.
