

BURR OAK TOWNSHIP MEETING MINUTES

March 7, 2022

MEMBERS PRESENT: G. Letts, Absent

VISITORS: Visitors were: Matt Craven, Gatha Pierucki, Anne Good, Library President and Jeff Brazo, Fire Board and Township Residents. Travis Klingler, Sturgist City Resident.

APPROVAL OF AGENDA: The agenda was approved by consensus.

COMMENTS FROM THE FLOOR : Jeff Brazo wanted to know about the construction of the 4th bay of the Fire Department. He also didn't think it should take 6-8 months to complete. Anne Good, Library President presented the board with handouts from the governor thanking the library and its employees for the excellent work it has done during COVID. She also asked for an increase in their budget to include \$18,0000 . They have not had an increase since 2018-2019 budget year. Anne also requested that the Board give them 4 Double faced shelving units to use for books at the library. The cost would be \$6,199.66. R. Baker made the motion to accept 2 units now from this budget and 2 later out of next years budget with M. Perry supporting . Motion carried.
